CONSENT ORDER

This cause having come to the attention of the Department of Agriculture and Consumer Services and a Settlement Agreement being executed on July 13, 1998, the Commissioner of Agriculture hereby finds as follows:

a. The Commissioner of Agriculture, as head of Department of Agriculture and Consumer Services (hereinafter the "Department"), has jurisdiction over the subject matter and the parties thereto.

b. The Department and Wima Corporation (hereinafter "Wima") have entered into the attached Settlement Agreement, which is incorporated herein by reference, resolving the issues in these two cases.

c. The entry of this Consent Order and compliance therewith by Wima shall conclude these two administrative actions.

IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. The Consent Order entered into between the parties is hereby approved.
2. The Department previously received and acknowledges payment of \$750 as settlement of the administrative fine.
3. The failure of Wima to meet any of the terms of the Consent Order may result in further action by the Department as authorized by law.


4. Each party hereto shall bear its own costs and attorney's fees, if any.
5. The parties have waived notice of their right to appeal and judicial review pursuant to Fla. Stat. § 120.569(1) and Fla. Stat. § 120.68.
