## FINAL ORDER

This cause was referred to the Division of Administrative Hearings for a formal administrative hearing. The assigned Administrative Law Judge ("ALJ") has submitted a Recommended Order to the Agency for Health Care The Recommended Order of June 25, 2001, Administration ("Agency"). entered herein is incorporated by reference.

## EXCEPTIONS

Counsel for the Petitioner, filed exceptions in numbered paragraphs one through twenty-one, which in effect are a global challenge of the ALJ's fact-finding and legal conclusions. The Petitioner excepts in whole or in part to findings of fact in paragraphs 4, 8, 9, 13, 15, 16, 17, 23, 25, 27, 29, 30, 31, 32, and 33. At this level of review the Agency has no authority to reweigh the evidence. The challenged findings are supported by competent, substantial evidence; therefore, the exceptions are denied. See e.g. Heifetz v. Dept. of <u>Business Regulation</u>, 475 So.2d 1277, 1281 (Fla. 1st DCA 1985). The Agency fully concurs with the ALJ's conclusions of law.

## FINDINGS OF FACT

The Agency hereby adopts the findings of fact set forth in the Recommended Order.

# **CONCLUSIONS OF LAW**

The Agency hereby adopts the conclusions of law set forth in the Recommended Order.

Based on the foregoing, the Petitioner, Full Health Care, Incorporated, is directed to refund Medicaid overpayments in the amount of \$193.232.50. Payment in full is due with 30 days of the filing of this Final Order unless the parties reach an agreement allowing the Petitioner to pay by monthly installments.
