

THIS CAUSE having come on for hearing before The School Board of Miami-Dade County, Florida, at its regular meeting of December 12, 2001, upon the Recommended Order by the duly appointed Administrative Law Judge, recommending that Andrea L. Demsey be dismissed from her employment with The School Board of Miami-Dade County, Florida, and the Board having been fully advised in the premises, it is hereby ordered by The School Board of Miami-Dade County, Florida, that:

1. The Administrative Law Judge's findings of fact, conclusions of law and recommendation, attached hereto, be and the same are hereby adopted as the Final Order of The School Board of Miami-Dade County, Florida;
2. Andrea L. Demsey's suspension without pay, as of October 11, 2000, is hereby sustained; and
3. Andrea L. Demsey be and is hereby dismissed from her employment with The School Board of Miami-Dade County, Florida, and shall forfeit all compensation for the period of her suspension.
