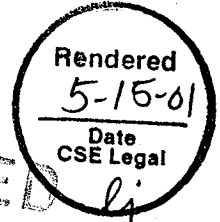

FINAL ORDER

Lillie Bogan, as Director of the Department of Revenue, Child Support Enforcement Program (DOR-CSE), being authorized by Section 409.25656, Florida Statutes, to levy on credits, or personal property belonging to persons who have a past due or overdue child support obligation, enters this Final Order as required by Chapter 120, Florida Statutes.

PRELIMINARY STATEMENT

1. Petitioner's last known address is Donald L. Baldwin, D.C. No. 048444, Tarpon Springs Work Release Center, 566 Brady Road, Tarpon Springs, Florida 34689.
2. By Notice of Intent to Levy dated August 10, 2000, DOR-CSE notified Petitioner that, pursuant to Section 409.25656, DOR-CSE intended to levy liquid assets belonging to the Petitioner in the control of MacDill Federal Credit Union.
3. Petitioner timely requested an administrative hearing before the Division of administrative hearings.

4. An administrative hearing was held by teleconference between Tallahassee, Florida and Tarpon Springs, Florida, on March 27, 2001 before Administrative Law Judge, Stephen F. Dean.

5. Judge Dean issued a Recommended Order in this Matter on May 3, 2001, a copy of which is attached hereto and incorporated by reference herein.

FINAL ORDER

BASED UPON the Findings of Fact and Conclusions of Law in the Recommended Order issued by Administrative Law Judge, Stephen F. Dean, on May 3, 2001, it is:

ORDERED that, pursuant to Section 409.25656, Florida Statutes, the Department of Revenue, Child Support Program may levy Petitioner's liquid assets in Petitioner's bank accounts at MacDill Federal Credit Union, apply the funds to reduce Petitioner's accrued child support arrearage, and credit Petitioner for said payment.


