FINAL ORDER

This cause was referred to the Division of Administrative Hearings for a formal administrative hearing. The Agency hereby adopts the findings of fact set forth in the Recommended Order.

CONCLUSIONS OF LAW

The Agency hereby adopts the conclusions of law set forth in the Recommended Order. In response to the Recommended Order, the licensee requested permission to pay the fine by monthly installments of \$200 each.

Based on the foregoing, the licensee, Marced, Incorporated, is found guilty of the violations of regulatory standards set forth in paragraphs 25 and 26 of the Recommended Order, and fines totaling \$1,900 are imposed. The licensee's request to pay in monthly installments is granted, with the first payment to be made no later than 30 days from the filing of this Final Order. Subsequent payments are due monthly no later than the tenth day of the month. Pay by check payable to Agency for Health Care Administration.
