FINAL ORDER

THIS CAUSE coming on to be heard before THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA (hereafter referred to as "THE SCHOOL BOARD") at its meeting conducted on July 17, 2001, to consider the Recommended Order filed on May 31, 2001 by John G. Van Laningham, Administrative Law Judge of the State of Florida Division of Administrative Hearings consisting of Findings of Fact, Conclusions of Law, and a Recommendation, and having considered the record, upon stipulation of the Parties and THE SCHOOL BOARD being fully advised in the Premises:

IT IS THEREUPON Ordered and Adjudged as Follows:

1. The Findings of Fact, Conclusions of Law and Recommendation contained in the Recommended Order are adopted in their entirety by THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA.
2. The Purchasing Department is directed to post a recommendation for award of a contract under Bid No. 21-076B to the lowest responsive, responsible bidder, in accordance with


the terms and conditions of the ITB. Such posting shall be conducted on July 24, 2001 at 3:00PM in accordance with Section 1.22 of the Special Conditions of Bid No. 21-076B.

3. The Purchasing Department is directed to release to Petitioner, School Food Service Systems, Inc., the protest bond it provided to THE SCHOOL BOARD in these proceedings.

4. The Petitioner, School Food Service Systems, Inc., is awarded costs that are assessed in the amount of \$3,387.55.


