FINAL ORDER

THIS CAUSE was heard on May 21, 2001 by the Board of Directors of Tampa Bay Water, A Regional Water Supply Authority ("Tampa Bay Water"), pursuant to Section 120.57(3), Florida Statutes, and Chapter 28-110, Florida Administrative Code, for the purpose of considering the Recommended Order of Administrative Law Judge Donald R. Alexander (ALJ) entered on May 4, 2001, and thereupon issuing a Final Order in the above-styled proceeding.

A copy of the Recommended Order issued by ALJ Alexander on May 4, 2001 is attached hereto as Exhibit "A". According to Section 120.57(3), Florida Statutes, and Rule 28-1.06.217(1), Florida Administrative Code, all parties were entitled to file written Exceptions to the ALJ's Recommended Order within ten (10) days of the date the Recommended Order was issued. However, none of the parties submitted any Exceptions to the Recommended Order.

The Board of Directors of Tampa Bay Water has reviewed the Recommended Order, and it is hereby adopted and incorporated by reference in its entirety.

WHEREFORE, the Board of Directors of Tampa Boy Water hereby orders that the Formal Protest filed by Universal Precision Industries, Inc., is denied and Contract No. 2001-22 is awarded to Commerce Controls, Inc.

Any party to this proceeding has the right to seek judicial review of this Final Order pursuant to Section 120.68, Florida Statutes, by filing a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the clerk of Tampa Bay Water, 2535 Landmark Drive, Suite 211, Clearwater, Florida 33761, and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 days from the date this Final Order is filed with the clerk of Tampa Bay Water.
