
Dear Judge Manry:

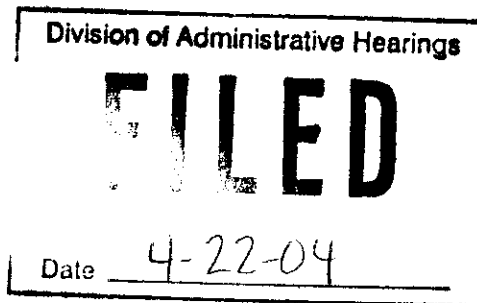
