FINAL ORDER

On June 28, 2001, petitioner, Public Consulting Group, Inc., filed with the Agency for Health Care Administration (Agency) its Formal Written Protest and Petition for Administrative Hearing challenging the Agency's intent to award a contract to Health Management Systems, Inc., based on the evaluation of proposals received in response to the Request for Proposals for Medicaid Third Party Recovery Services, Proposal No. RFP TPL 01-01.

On July 19, 2001, the formal protest was referred to the Division of Administrative Hearings (DOAH) for further proceedings. The assigned Administrative Law Judge, Robert E. Meale, submitted a Recommended Order to the Agency on September 18, 2001. The order recommended that the Agency enter a final order awarding the contract in question to

Intervenor, Health Management Systems, Inc. The Recommended Order is attached hereto and incorporated herein.

EXCEPTIONS

Exceptions to the Recommended Order were filed by Intervenor on September 28, 2001, but were subsequently withdrawn on October 1, 2001.

FINDINGS OF FACT

The Agency hereby adopts the findings of fact set forth in the Recommended Order, except to correct three scrivener's errors. The scrivener's error on page 13, paragraph 27, second sentence, is corrected to reflect that Petitioner, not Intervenor, filed the notice of protest. The sentence is corrected to read as follows:

On the basis of these scores, Respondent proposed the selection of Intervenor's proposal, and Petitioner timely filed a notice of protest and formal written protest.

Another scrivener's error confusing the Petitioner and Intervenor is located on page 3, first paragraph, last line, which incorrectly reads that "the disqualification of Intervenor's proposal would leave Intervenor's proposal as the highest remaining responsive proposal...." The second "Intervenor's" in the sentence is corrected to read "Petitioner's."

Finally, on page 5, paragraph 1, at the end of the first sentence, the "Proposal No." is designated as "Proposal No. RFP TPR 01-01 (RFP)." This is corrected to read, "Proposal No. RFP TPL 01-01 (RFP)."

CONCLUSIONS OF LAW

The Agency hereby adopts the conclusions of law set forth in the Recommended Order.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is **ORDERED:**

The Agency for Health Care Administration will award to Health Management Systems, Inc., the proposed contract in accordance with and subject to the requirements of the Request for Proposals for Medicaid Third Party Recovery Services, Proposal No. RFP TPL 01-01, and the proposal submitted by Health Management Systems, Inc., in response to the RFP.
