NOTICE OF APPEAL RIGHTS: Pursuant to Section 120.68, Florida Statutes, a party to this Final Order may seek judicial review of this Final Order in the appropriate district court of appeal by filing a notice of appeal pursuant to Florida Rules of Appellate Procedure 9.110(c). The original notice of appeal shall be filed with Glenda Hagan, Agency Clerk, Gilchrist County Public Schools, 310 NW 11th Avenue, Trenton, Florida 32693 on or before 30 days from the date of this final order. A copy of the notice, together with the appropriate filing fee, shall also be filed with the Clerk, District Court of Appeal, First Appellate District, 301 Martin Luther King, Jr. Boulevard, Tallahassee, Florida 32399-1850. If the 30th day following the date of the filing of this order with the Agency Clerk falls on a Saturday, Sunday or a day when the school board office is otherwise closed, the notice of appeal must be filed on the next day that the school board office is open for business. If you fail to file your notice of appeal within the time prescribed by law and the rules of court, you will lose your right to appeal this final order.
