



Re: Duval County School Board v. Sakina A. Jones

As required by subsection 120.57(1)(m), Florida Statute, Duval County Public Schools is attaching a copy of the Final Order(s), along with any exceptions for Sakina A. Jones, a former employee of Duval County Public Schools.

Ms. Jones was suspended without pay effective February 15, 2002 through May 28, 2002. On November 14, 2002, Administrative Law Judge P. Michael Ruff recommended, "That a final order be entered by the School Board of Duval County compensating the Respondent for the salary and benefits to which she is entitled from the date of her termination of employment (suspension without pay) forward to the end of the 2001-2002 School Year." As final agency action on the matter, Duval County School Board took administrative action based on the Recommended Order and Ms. Jones was thereafter suspended with pay effective February 15, 2002 through May 28, 2002. Her employment with Duval County Public Schools was terminated effective May 28, 2002. To comply with the aforementioned Florida law, attached are the following documents:
