

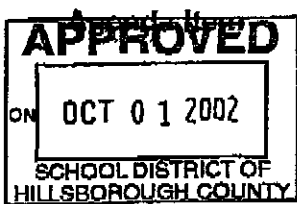

EXECUTIVE SUMMARY:
