FINAL ORDER

This matter comes before the Department of Corrections (the "Department") for consideration and final agency action after an administrative hearing was conducted before Administrative Law Judge Charles C. Adams, Division of Administrative Hearings. A Recommended Order was rendered by the Administrative Law Judge on February 26, 2003. Pursuant to section 120.57(1)(b)(9), Florida Statutes, and Florida Administrative Code Rule 33-20.005, the parties were allowed ten (10) days to file exceptions to the Recommended Order. No exceptions to the Recommended Order have been filed.

Based upon the complete record submitted to the Department by the Division of Administrative Hearings, together with the Recommended Order, the Department makes the following findings:


FINDINGS OF FACT/CONCLUSIONS OF LAW

1. The Department adopts and incorporates into this Final Order the Recommended Order, including the Findings of Fact and Conclusions of Law.

2. As recommended by the Administrative Law Judge, the Department's actions with respect to the Invitation to Bid for security windows are affirmed. The formal written protest is hereby DISMISSED WITH PREJUDICE.

This order may be appealed within thirty days by filing a notice of appeal with the agency and the district court of appeal. Except in cases of indigence, the court will require a filing fee and the agency will require payment for preparing the record on appeal. For further explanation of the right to appeal, refer to section 120.68, Florida Statutes, and the Florida Rules of Appellate Procedure.
