- The parties and the Judge discussed the appropriate statutes to refer a. These discussions appear on page 23-31 of the Official to in regard to this matter. Transcript. The parties and the Judge agreed to the following:
- (1) The Alu-O'Hara Act §112.19(1)(a) was promulgated in 1996 and first appeared in the 1997 statutes and therefore reference to the 1997 statutes would have been clearly appropriate. [See also p. 9 Conclusions of Law - Respondent's Proposed Recommended Order]
- (2) The dates of the relevant injuries were September 1994 and January 1995 and therefore reference to Chapter 440 in Florida Statutes 1994 would also have been clearly appropriate.
