Final Order

This matter was heard by a Teacher Panel of the Education Practices Commission pursuant to Sections 1012.795, 1012.796 and 120.57(1), Florida Statutes, on January 23, 2004 in Orlando, Florida, for consideration of the Recommended Order entered in this case by Suzanne F. Hood, Administrative Law Judge. Neither party filed Exceptions to After reviewing the complete record accompanying the Recommended Order. Recommended Order, and being otherwise fully advised in the premises, the Panel hereby adopts the findings of fact, (paragraphs 1 - 29), conclusions of law, (paragraphs 30 - 49). and recommendation contained in the Recommended Order, and said Recommended Order, a copy of which is attached and made a part hereof, is hereby adopted in full and becomes the Final Order of the Education Practices Commission.

It is therefore **ORDERED** Betty Goggins is guilty of violating Section 1012.795(I)(i). Florida Statutes, and Rules 6B-1.006(4)(b), 6B-1.006 (5)(a), and (h), Florida Administrative Code.

It is further **ORDERED** that

Upon employment in any public or private position requiring a Florida educator's certificate, Ms. Goggins shall be placed on 5 employment years of probation with the conditions that during that period, she shall:

1. Notify the EPC immediately upon employment and immediately upon termination

of employment, in any public or private position requiring a Florida educator's certificate.

- 2. Have immediate supervisor submit annual performance reports to the EPC.
- 3. Violate no law and fully comply with all district school board regulations, school rules, and State Board of Education Rule 6B-1.006, Florida Administrative Code.
 - 4. Satisfactorily perform assigned duties in a competent, professional manner.
- 5. During the first six months of each probation year, pay to the EPC the sum of \$150.00 to defray the cost of monitoring probation during that year.
 - 6. Not administer or proctor any standardized tests.
 - 7. Bear all costs of complying with the terms of this probation.

This Order takes effect upon filing with the Clerk of the Education Practices Commission. DONE AND ORDERED, this Hay of February, 2004.
