SUPPLEMENTAL ARBITRATION AWARD

By correspondence filed June 7, 2005, Claimant advises that the two pending issues, medical expenses and attorney's fees and costs, have been amicably resolved by the parties without the need to re-convene the arbitration panel in this proceeding. Accordingly, the collateral issue of the amount of arbitrators' fees has become fixed.

The Arbitration Award announced on the record at the conclusion of the arbitration hearing on April 27, 2005, and reduced to writing on April 29, 2005, and the Amended Arbitration Award entered on May 24, 2005, are supplemented as follows:

Adjusted medical expenses: \$ 11,252.74
Attorney's fees and costs: 162,892.35

These amounts, together with the amounts set forth in the Arbitration Award and in the Amended Arbitration Award, constitute the total award in this cause.

Arbitrators Massa and Watson each expended 23 hours in this matter, and Defendants agreed on the record during the arbitration hearing to pay Arbitrators Massa and Watson at the rate of \$250 per hour. Accordingly, Defendants shall pay each of them the sum of \$5,750 forthwith.
