FINAL ORDER

The Recommended Order concluded that the evidence supporting the Department's determination to revoke petitioner's family day care home license was not clear and convincing, and that the Department should reinstate petitioner's license. No exceptions to the Recommended Order have been filed. The Recommended Order is approved and adopted.

Accordingly, petitioner's family day care home license is reinstated. It appears in the record that petitioner had ceased operating the family day care home upon receipt of the Department's notification of intent to revoke the license. Prior to reinstating the license, the Department's licensing staff will inspect the facility to ensure that petitioner is currently able to operate in accordance with the applicable child care standards

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


