## FINAL ORDER

A recommended order having been received, this matter is before Department of Health (Department) for the entry of a final order. At issue is the citation imposing a fine on the Respondent for installing an on-site sewage treatment and disposal system (septic tank) without first obtaining a permit from the Polk County Health Department.

The Administrative Law Judge recommends that a fine of five hundred dollars (\$500) be imposed on the Respondent for violating the statutory and rule requirement of a permit. Although he declined to attend the final hearing held in this proceeding, the Respondent filed a "Response to Recommended Order", which is deemed to be exceptions allowed by Section 120.57(1)(k), Florida Statutes. The same provision also requires each exception to identify the disputed portion of the recommended order, identify the legal basis for the exception, and include a specific citation to the record.

The Respondent identifies the paragraphs of the recommended order he disputes, but otherwise his exceptions do not sufficiently comply with Section 120.57(1)(k), Florida Statutes, to enable meaningful consideration. It is noted that the Respondent's primary objection to the recommended

order is that administrative adjudication is unconstitutional; therefore he maintains there is no jurisdiction over him for this proceeding, and the findings and conclusions of the Administrative Law Judge are extra vires. It is long settled that executive agencies may conduct quasi-judicial proceedings. See, e.g., Koehler v. Florida Real Estate Commission, 390 So.2d 711 (Fla. 1980). The exceptions are without legal foundation.

The recommended order of November 30, 2004 is incorporated by reference. The findings, conclusions, and recommendation set forth in the recommended order are adopted.

Based on the foregoing, a fine of five hundred dollars (\$500) is imposed on the Respondent. Payment in full is due no later than 30 days after the filing date of this final order. Pay by check or money order payable to the Department of Health and mail payment to Roland Reis, Polk County Health Department, 1290 Golfview Avenue, 4<sup>th</sup> floor, Bartow, Florida 33830-6740.
