FINAL ORDER

This cause came on for consideration of and final agency action on a Recommended Order rendered on June 8, 2006, after a hearing was conducted pursuant to Sections 120.569 and 120.57(1), Florida Statutes by Administrative Law Judge, Linda M. Rigot. The Department filed a Proposed Recommended Order; the Respondent did not. Neither party filed exceptions. The transcript of proceedings, the exhibits introduced into evidence, the Department's Proposed Recommended Order, and the Recommended Order have all been considered in the rendering of this Final Order.

IT IS HEREBY ORDERED that the Findings of Fact and Conclusions of Law made by the Administrative Law Judge are adopted herein as the Department's Findings of Fact and Conclusions of Law.


IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted by the Department, and that H.R. Electric, Inc. is directed to pay the sum of \$250,871.02 to the Department within thirty days from the date hereof.

ACCORDINGLY, IT IS HEREBY FURTHER ORDERED that the Stop Work Order and Order of Penalty Assessment and the Fourth Amended Order of Penalty Assessment entered by the Division of Workers' Compensation is affirmed, and that H.R. Electric, Inc. shall cease all business operations unless and until it provides evidence satisfactory to the Division of Workers' Compensation of having now complied with the workers' compensation law by securing the necessary workers' compensation covered for covered employees and, pursuant to Section 440.107(7)(a), Florida Statutes, paid the civil penalty imposed herein.

NOTICE OF RIGHTS

Any party to these proceedings adversely affected by this Order is entitled to seek review of this Order pursuant to Section 120.68, Florida Statutes, and Fla. R. App.P. 9.110. Review proceedings must be instituted by filing a petition or notice of appeal with the General Counsel, acting as the agency clerk, at 612 Larson Building, Tallahassee, Florida 32399-0333, and a copy of the same and the appropriate filing fee with the appropriate District Court of Appeal within thirty (30) days of rendition of this Order.
