AMENDED¹ FINAL ORDER

THIS CAUSE is before me on the Recommended Order of Daniel M. Kilbride,

Administrative Law Judge, Division of Administrative Hearing, dated October 5, 2004.

Although afforded the opportunity to submit exceptions to the Recommended Order, neither party elected to do so.

Having considered the Recommended Order, the pertinent parts of Chapter 65C-22, Florida Administrative Code, and sections 402.206 through 402.319, Florida Statutes (2004), it is hereby ordered that the Findings of Facts and Conclusions of Law of the administrative law judge be and are hereby approved and adopted, with the exception of the conclusion in paragraph 21 that the Department's burden of proof with regard to denial of license renewal is clear and convincing evidence. That conclusion is inconsistent with the decision in <u>Department of Banking and Finance v. Osborne Stern & Co.</u>, 670 So. 2d 932

932 (Fla. 1996)². It is further ordered that the administrative fine or penalty imposed against Respondent is \$200.00, payable as required by law. It is further ordered that Respondent's license is suspended for a period of one (1) month, followed by the issuance of a provisional license, effective the date of receipt of this Order by Respondent.

NOTICE OF RIGHT TO APPEAL

As the <u>Coke</u> court expressly stated, the issue was conceded, and not litigated, in that case. The court did not, therefore, consider the issue on the merits.

Appeal," accompanied by the filing fee required by law, with the First District Court of Appeal in Tallahassee, Florida, or with the District Court of Appeal in the district where the party resides. The Notices must be filed within thirty (30) days of the rendition of this final order.³

³ The date of the "rendition" of this Final Order is the date that is stamped on its first page. The Notices of Appeal must be <u>received</u> on or before the thirtieth day after that date.
