FINAL ORDER DISMISSING PETITION FOR RELIEF FROM AN UNLAWFUL EMPLOYMENT PRACTICE

This matter is before the Commission for consideration of the Recommended Order, dated December 7, 2005, issued in the above-styled matter by Administrative Law Judge Ella Jane P. Davis.

Findings of Fact and Conclusions of Law

Judge Davis' order reflects that Petitioner failed to appear at the scheduled administrative hearing in the matter. Consequently, Judge Davis recommended the Commission issue a final order dismissing the matter based on Petitioner's lack of presentation of a prima facie case of discrimination. Judge Davis also concluded that "Petitioner's failure to appear is the equivalent of a voluntary dismissal of the Petition for Relief."

We adopt the Administrative Law Judge's finding as to the nonappearance of Petitioner and conclude that Petitioner has failed to carry his burden of proof.

Exceptions

Neither party filed with the Commission exceptions to the Administrative Law Judge's Recommended Order.

Petitioner did file with the Division of Administrative Hearings and explanation as to his nonappearance at the scheduled administrative hearing, but we note that the Recommended Order specifically finds that Petitioner was instructed by the Administrative Law Judge's secretary that he should appear at the hearing as scheduled.

Dismissal

The Petition for Relief and Complaint of Discrimination are DISMISSED with prejudice. The parties have the right to seek judicial review of this Order. The Commission and the appropriate District Court of Appeal must receive notice of appeal within 30 days of the date this Order is filed with the Clerk of the Commission. Explanation of the right of appeal is found in Section 120.68, Florida Statutes, and in the Florida Rules of Appellate Procedure 9.110.
