## FINAL ORDER

A recommended order having been received, this matter is before Department of Health (Department) for disposition. At issue is the administrative complaint charging the Respondent with two counts of providing services as a septic tank contractor without registration with the Department as required by section 381.0056(4) and chapter 489, part III, Florida Statutes. The Administrative Law Judge finds that both counts were proved by clear and convincing evidence. Accordingly, the Respondent is found guilty of both counts. The recommended order of July 28, 2005 is adopted and incorporated by reference.

Based on the foregoing, the "Order to Cease Operation" of January 26, 2005 remains effective until further notice and fines totaling one thousand dollars (\$1,000) are imposed. Payment in full is due no later than 30 days after the filing date of this final order. If requested by the Respondent, the Lee County Health Department may authorize payment of the fines by monthly installment payments.
