FINAL ORDER

This cause came on for consideration of and final agency action on a Recommended Order rendered on September 15, 2005, after a hearing conducted pursuant to Sections 120.57(1), and 120.569, Florida Statutes, by Administrative Law Judge Don W. Davis. The exhibits introduced into evidence, the Proposed Recommended Order, and the Recommended Order, have all been considered during the promulgation of this Final Order. No exceptions to the Recommended Order were filed by either party.

So as to correct a typographical error in the style of the case, a comma is inserted between "Snyder" and "Martin" and the style of the case is amended to read "Snyder, Martin, d/b/a Affordable Fencing".

Upon examination of the record and evidence admitted at hearing (Petitioner's Exhibits A-N) and so as to correct a typographical error in the "Preliminary Statement" section of the Recommended Order, the number of exhibits presented by the Petitioner is amended to "14".

IT IS HEREBY ORDERED that the Findings of Fact and Conclusions of Law made by the Administrative Law Judge are adopted as the Department's Findings of Fact, and Conclusions of Law.

IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted by the Department, and that Snyder, Martin, d/b/a Affordable Fencing, is directed to pay the sum of \$200,594.12 to the Department within thirty days from the date hereof.

ACCORDINGLY, IT IS HEREBY FURTHER ORDERED that the Stop Work Order and Order of Penalty Assessment, Amended Order of Penalty Assessment, and Corrected Amended Order of Penalty Assessment entered by the Division of Workers' Compensation are affirmed, and that Snyder, Martin, d/b/a Affordable Fencing, shall cease all business operations unless and until it provides evidence satisfactory to the Division of Workers' Compensation of having now complied with the workers' compensation law by securing the necessary workers' compensation coverage for covered employees and, pursuant to Section 440.107(7)(a), Florida Statutes, paid the civil penalty imposed herein.

NOTICE OF RIGHTS

Any party to these proceedings adversely affected by this Order is entitled to seek review of this Order pursuant to Section 120.68, Florida Statutes, and Fla. R. App.P. 9.110. Review proceedings must be instituted by filing a petition or notice of appeal with the General Counsel, acting as the agency clerk, at 612 Larson Building, Tallahassee, Florida 32399-0333, and a copy of the same and the appropriate filing fee with the appropriate District Court of Appeal within thirty (30) days of rendition of this Order.
