FINAL ORDER

A recommended order having been received, this matter is before Department of Health (Department) for disposition. At issue is the citation of March 10, 2004, charging the Respondent with violations of Chapter 64E-6, Standards for Onsite Sewage Treatment and Disposal Systems; specifically, three violations of section 64E-6.022, Florida Administrative Code as follows: one, completing contracted repairs without obtaining a permit, two, failure to call for required inspection of repairs, and three, repair of a septic tank system in violation of statutory and rule standards. The Administrative Law Judge recommends finding the Respondent guilty of the charged violations, and imposing a fine of one thousand dollars (\$1,000).

The recommended order dated December 6, 2005 is adopted and incorporated by reference.

Based on the foregoing, the Respondent, James L. Smith, is found guilty of the charged violations, and a fine of one thousand dollars (\$1,000) is imposed. Payment in full is due no later than 30 days after the filing date of this final order.
