**ORDER REMANDING PETITION FOR
RELIEF FROM AN UNLAWFUL EMPLOYMENT PRACTICE**

This matter is before the Commission for consideration of the Recommended Order, dated April 20, 2006, issued in the above-styled matter by Administrative Law Judge Barbara J. Staros.

Findings of Fact and Conclusions of Law

I note that the Post Office Box number to which Petitioner's copy of the Recommended Order was sent by the Division of Administrative Hearings appears to be incorrect. I am concerned that Petitioner may not have received a copy of the Recommended Order; thereby impacting Petitioner's ability to file exceptions to the Recommended Order should Petitioner desire to do so.

The address to which the Recommended Order was sent to Petitioner's counsel appears to be Post Office Box 44195, Jacksonville, FL 32222 (omitting the "4" that is the fourth digit of the Post Office Box Number).

Consequently, the matter is remanded to the Division of Administrative Hearings for the re-issuance of the Recommended Order, starting anew Petitioner's time for filing exceptions.


Exceptions

Neither party filed exceptions to the Administrative Law Judge's Recommended Order.


Remand
