### FINAL ORDER

THIS CAUSE came on to be heard before the Florida Real Estate Commission ("Commission") pursuant to Sections 120.569 and 120.57(1), Florida Statutes, on February 20, 2007, in Pensacola Beach, Escambia County, Florida, for the purpose of considering Administrative Law Judge Charles C. Adams's Recommended Order in the above styled case. A copy of said Recommended Order is attached hereto and incorporated as Exhibit "A."

Respondent was not present. The Petitioner was represented by Mr. S.N. Persaud, Esquire, Senior Attorney for the Department of Business and Professional Regulation, Division of Real Estate, Orlando, Orange County, Florida. The Commission was represented by Tom Barnhart, Assistant Attorney General, Tallahassee, Leon County, Florida. The Commission denied Respondent's request to continue the hearing.

After a review of the complete record in this matter, including consideration of the Administrative Law Judge's Recommended Order and the arguments of each party, the Commission makes the following findings of fact and conclusions of law:

# Findings of Fact

- 1. The Administrative Law Judge's findings of fact as set forth in the Exhibit "A" are approved, adopted, and incorporated herein by reference.
- 2. There is competent, substantial evidence to support the Administrative Law Judge's findings of fact as adopted by the Commission.

## Conclusions of Law

3. The Board has jurisdiction of this matter pursuant to Sections 120.569 and 120.57(1), Florida Statutes, Chapter 475, Part I, Florida Statutes, and Chapter 61J2 of the Florida Administrative Code.

- 4. The Administrative Law Judge's conclusions of law as set forth in Exhibit "A" are approved, adopted, and incorporated herein by reference.
- 5. There is competent, substantial evidence to support the Administrative Law Judge's conclusions of law in Exhibit "A" as amended and adopted by the Commission.

#### DISPOSITION

6. The Administrative Law Judge's Recommendation is approved and adopted by the Commission in its entirety.

WHEREFORE, IT IS HEREBY ORDERED and ADJUDGED that:
Respondent's real estate broker licenses 3000807, 3000808,
and 3092222 and real estate instructor license 32195 are
REVOKED. This Final Order shall take effect upon being
filed with the Clerk of the Department of Business and
Professional Regulation.
