FINAL ORDER DETERMINING SALARY OVERPAYMENT

This matter is now before the undersigned for issuance of final agency action in regard to the Petitioner's claim that the Department improperly determined that he had received \$2214.12 in salary overpayment. A formal hearing was conducted on the Petitioner's claim before Administrative Law Judge Harry L. Hooper on July 11, 2006.

A Recommended Order was entered on July 26, 2006, concluding that the Petitioner was overpaid in the amount of \$2214.12. The ALJ recommended that the Department enter a final order finding the Petitioner liable to repay \$2214.12 for what should have been leave without pay. No exceptions were filed.

Based upon the foregoing it is hereby **ORDERED**:


1. The Administrative Law Judge's Findings of Fact and Conclusions of Law are adopted.


2. The Petitioner was paid \$2214.12 in error, for which amount he owes the State of Florida.

Notice of Right to Judicial Review

In accordance with the provisions of section 120.68, Florida Statutes, a party who is adversely affected by this Final Order is entitled to judicial review. Review proceedings are governed by the Florida Rules of Appellate Procedure. Such proceedings are commenced by filing a notice of appeal with the Agency Clerk, Office of the General Counsel, 2737 Centerview Drive, Suite 312, Tallahassee, Florida 32399-3100, and a copy, accompanied by filing fees prescribed by section 35.22, Florida Statutes, with the District Court of Appeal, First District, 301 Martin Luther King, Jr., Boulevard, Tallahassee, Florida 32399-1850, or with the District Court of Appeal in the appellate district where the party resides. The notice of appeal must be filed within 30 days of rendition of the order to be reviewed.
