The Recommended Order concluded that revocation of Respondent's child care facility license was an appropriate sanction. No exceptions to the Recommended Order were filed. The Recommended Order is approved and adopted.

Accordingly, Respondent's license to operate a child care facility is

REVOKED pursuant to section 402.310, Florida Statutes.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


