FINAL ORDER

Petitioner challenged the decision to administratively withdraw her from the Bradford-Union Area Vocational Technical Center pursuant to the termination letter issued February 22, 2006 by Clarence DeSue, Director of the Bradford-Union Area Vocational Technical Center. A disputed-fact hearing occurred on November 13, 2006 before the Honorable Ella Jane P. Davis, Administrative Law Judge, Division of Administrative Hearings. ALJ Davis issued a Recommended Order on February 9, 2007. This matter comes before the Bradford County School Board for review and adoption, rejection or modification of said Recommended Order.

The Bradford-Union Area Vocational Technical Center is located in Bradford County, Florida and is operated pursuant to Section 1001.44, Florida Statutes by the Bradford County School Board as such the Bradford County School Board is the appropriate entity to enter the Final Order in this matter.

The Bradford County School Board has reviewed the Recommended Order entered by the Honorable Ella Jane P. Davis on or about February 9, 2007. The Bradford County School Board notes that no exceptions to the Recommended Order were filed by either party.

At its public session held on Monday, March 12, 2007, the Bradford County School Board considered the Recommended Order and the comments of counsel for the Bradford-Union Area Vocational Technical Center who was present during the session.

Upon due consideration, it is hereby ORDERED by the Bradford County School Board that:

- 1. The Recommended Order issued by the Honorable Ella Jane P. Davis, Administrative Law Judge, on February 9, 2007, a complete copy of which is attached hereto, incorporated herein and identified as Exhibit "A", is accepted in its entirety.
- 2. The February 22, 2006 Administrative Withdrawal letter issued to the Petitioner by Clarence DeSue, Director of the Bradford-Union Area Vocational Technical Center, is hereby ratified.
- 3. Accordingly, the Petitioner is deemed to have been administratively withdrawn from the Bradford-Union Area Vocational Technical Center effective February 22, 2006.
