AMENDED FINAL ORDER

THIS CAUSE is before me for entry of a Final Order. In accordance with the opinion in Haines v. Department of Children and Families, 2007 WL 5082522 (Fla. 5th DCA, April 11, 2008), the May 22, 2007, Final Order issued in this case is VACATED. The Recommended Order issued February 21, 2007, is approved and adopted. Respondent's foster care license shall be reinstated and the license period shall continue as if the revocation had not occurred. In this case, respondent's license had approximately 90 days remaining prior to expiration at the time it was revoked. The license shall be reinstated for a period of not less than 90 days. If respondent desires to renew the license, respondent should submit a renewal application as required by section 409.175, Florida Statutes, and chapter 65C-13, Florida Administrative Code. The Department shall not

consider the allegations in this case in any way when evaluating respondent's renewal application.

RIGHT TO APPEAL

A PARTY WHO IS ADVERSELY AFFECTED BY THIS FINAL ORDER IS ENTITLED TO JUDICIAL REVIEW PURSUANT TO SECTION 120.68, FLORIDA STATUTES, WHICH SHALL BE INSTITUTED BY FILING ONE COPY OF A NOTICE OF APPEAL WITH THE AGENCY CLERK OF THE DEPARTMENT OF CHILDREN AND FAMILIES, AND A SECOND COPY ALONG WITH FILING FEE AS PRESCRIBED BY LAW, IN THE FIRST DISTRICT COURT OF APPEAL OR IN THE DISTRICT COURT OF APPEAL WHERE A PARTY RESIDES. REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


