FINAL ORDER

On November 29, 2006, the Department of Transportation (Department) issued a Notice of Denied Application to Lamar Advertising of Ft. Walton Beach (Lamar). The notice informed Lamar that two sign permit applications were being denied because the sign would not be located within in an area that met the permitting requirements of Chapter 479, Florida Statutes. On December 19, 2006, Lamar filed a Request for Formal Hearing.

On January 22, 2007, the Department issued an Order of Dismissal because Lamar's hearing request did not meet the requirements for requesting an administrative hearing. On February 1, 2007, Lamar filed an Amended Petition for Formal Hearing. The matter was referred to the Division of Administrative Hearings (DOAH) on February 15, 2007, for assignment of an administrative law judge and a formal hearing.

On June 6, 2007, a formal administrative hearing was held in Fort Walton Beach,

Florida, before Diane Cleavinger, a duly appointed administrative law judge. Appearances on behalf of the parties were as follows:

Larnar presented the testimony of three witnesses: Chad Pickens, Billy Wayne Strickland, and Larry Wayne Adkinson, and offered eight exhibits that were admitted into evidence. The Department presented the testimony of Billy Wayne Strickland and offered seven exhibits that were admitted into evidence.

A transcript of the final hearing was filed on July 16, 2007. Both parties timely filed proposed recommended orders. On October 4, 2007, the record was reopened for submission of one additional exhibit from Lamar. A Recommended Order was issued December 13, 2007. No exceptions were filed.

STATEMENT OF THE ISSUE

The issue in this case is whether the proposed sign site qualifies as an unzoned commercial or industrial area under Section 479.01(23); Florida Statutes.

FINDINGS OF FACT

The administrative law judge's Findings of Fact in paragraphs 1 through 20 are supported by competent, substantial evidence, and are adopted and incorporated as if fully set forth herein.

CONCLUSIONS OF LAW

- 1. The Department has jurisdiction over the parties and the subject matter of this proceeding pursuant to Chapters 120 and 479, Florida Statutes.
- 2. The Conclusions of Law contained in paragraphs 21 through 32 of the Recommended Order are fully supported by law and incorporated as if fully set forth herein.

<u>ORDER</u>

Based on the foregoing Findings of Fact and Conclusions of Law, it is

ORDERED that Lamar Advertising Company of Ft. Walton Beach's applications for outdoor advertising sign permits (application numbers 56274 and 56275) for a two-sided sign structure to be located .10 miles south of South Bay Grove Road on U.S. 331 in Walton County, Florida, are granted.
