FINAL ORDER

This matter came before the Criminal Justice Standards and Training Commission (the Commission) at a public meeting on December 6, 2007, in Tallahassee, Florida. It was alleged by Administrative Complaint that the Respondent had violated specified sections of Chapter 943, Florida Statutes, and Chapter 11B-27, Florida Administrative Code. In accordance with §§120.569 and 120.57(1), Florida Statutes, a formal hearing was held on this matter, and a Recommended Order was submitted by an administrative law judge from the Division of Administrative Hearings to the Commission for consideration. The Commission further approves the administrative law judge's recommendations without modification.

It is therefore ORDERED AND ADJUDGED that the Respondent's abovereferenced criminal justice certification is hereby REVOKED.
