FINAL ORDER

An Administrative Law Judge of the Division of Administrative Hearings has entered an Order Closing File in this proceeding. A copy of the Order is attached to this Final Order as Exhibit A.

BACKGROUND

This is a proceeding to determine whether the City of Leesburg's Comprehensive Plan Amendments adopted by Ordinance Nos. 06-136 through 06-139, 06-141, 06-143, and 06-149 on December 18, 2006, and Ordinance Nos. 07-50, 07-51, 07-53 through 07-56, 07-59, and 07-63 through 07-65 on July 9, 2007 (collectively, "Amendments"), are "in compliance" with the Local Government Comprehensive Planning and Land Development Regulation Act, Ch. 163, Part II, Florida Statutes.

FINAL ORDER NO. DCA10-GM-112

The City and the Department entered into a Stipulated Settlement Agreement which required the City to adopt remedial amendments ("Remedial Amendments"). The City adopted the Remedial Amendments and, on December 3, 2009, the Department subsequently published its Cumulative Notice of Intent to find the comprehensive plan amendments at issue in this proceeding, as remediated, "in compliance" with Chapter 163, Part II, Florida Statutes, and Rule 9J-5, Florida Administrative Code.

The Department subsequently filed with the Division of Administrative Hearings a Motion to Close File and Relinquish Jurisdiction. On January 22, 2010, the Administrative Law Judge issued his Order Closing File. No Exceptions to the Administrative Law Judge's Order were filed.

ORDER

WHEREFORE, it is ORDERED that the above-captioned proceeding is DISMISSED, and the Agency Clerk is directed to close the file.



THE NOTICE OF APPEAL MUST BE SUBSTANTIALLY IN THE FORM PRESCRIBED BY FLORIDA RULE OF APPELLATE PROCEDURE 9.900(a). A COPY OF THE NOTICE OF APPEAL MUST BE FILED WITH THE APPROPRIATE DISTRICT COURT OF APPEAL AND MUST BE ACCOMPANIED BY THE FILING FEE SPECIFIED IN SECTION 35.22(3), FLORIDA STATUTES.

YOU WAIVE YOUR RIGHT TO JUDICIAL REVIEW IF THE NOTICE OF APPEAL IS NOT TIMELY FILED WITH THE AGENCY CLERK AND THE APPROPRIATE DISTRICT COURT OF APPEAL.
