This cause came on for consideration of and final agency action on the Recommended Order submitted on April 9, 2008 by Administrative Law Judge Bram D.E. Canter pursuant to a formal hearing conducted under the authority of and pursuant to Section 120.57(1), Fla. Stat., on January 15, 2008. No exceptions were filed.

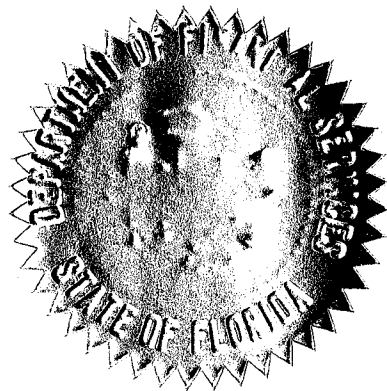
IT IS HEREBY ORDERED AND ADJUDGED that the Findings of Fact and Conclusions of Law in the Recommended Order are adopted as the Department's Findings of Fact and Conclusions of Law, and


IT IS FURTHER ORDERED AND ADJUDGED that in conformity with the Administrative Law Judge's Findings of Fact and Recommendation, the penalty to be assessed in this cause is re-calculated in accordance therewith to be reduced to the sum of \$7, 649.72.

IT IS THEREFORE ALSO ORDERED that Plumb Structures, Inc., shall pay the sum of \$7, 649.72 to the Department within thirty days from the date hereof, and that

the Order of Penalty Assessment, as modified above, and the Stop Work Order entered by the Division of Workers' Compensation are affirmed, and that Plumb Structures, Inc., shall cease all business operations unless and until it provides evidence satisfactory to the Division of Workers' Compensation of having now complied with the workers' compensation law by securing the necessary workers' compensation coverage for covered employees and, pursuant to Section 440.107(7)(a), Florida Statutes, paying the civil penalty imposed herein.
