

The Recommended Order concludes that the Department presented clear and convincing evidence that respondent committed repeated serious violations of section 402.313, Florida Statutes, such that revocation of respondent's registration to operate a family day care home should be revoked. REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


