FINAL ORDER

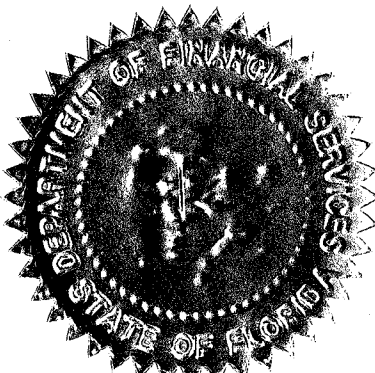
