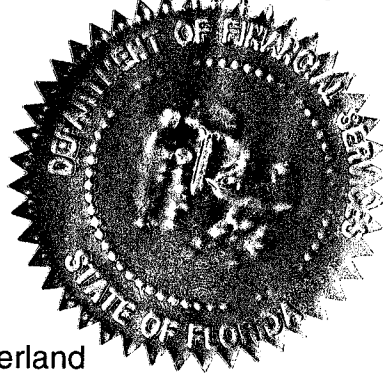
After review of the record, including the transcript of proceedings and admitted exhibits, and being otherwise fully apprised in all material premises,


IT IS HEREBY ORDERED that the Findings of Fact made by the Administrative Law Judge are adopted as the Department's Findings of Fact, and that the Conclusions of Law reached by the Administrative Law Judge are adopted as the Department's Conclusions of Law.

IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted by the Department, and that Respondent, Randall Lee Southerland, is directed to pay the sum of \$1,168.68, to the Department within thirty days from the date hereof.

IT IS HEREBY FURTHER ORDERED that the Stop Work Order and Amended Order of Penalty Assessment entered by the Division of Workers' Compensation is affirmed, and that the Respondent, Randall Lee Southerland, shall cease all business operations unless and until he provides evidence satisfactory to the Division of Workers' Compensation of having now complied with the workers' compensation law by securing the necessary workers' compensation insurance coverage for covered employees and, pursuant to Section 440.107(7)(a), Florida Statutes, paying the civil penalty imposed herein.
