BACKGROUND

This is a proceeding to determine whether the public schools interlocal agreement (ILA) entered into by Hernando County,

Brooksville, and Hernando County School Board, DCA docket no. 2701, is consistent with the minimum requirements of Sections
163.31777(2) and (3), Florida Statutes, and the Local Government
Comprehensive Planning and Land Development Regulation Act, Ch.
163, Part II, Florida Statutes (the "Act").

All parties to this proceeding entered into a Stipulated Settlement Agreement resolving the issues in this case through the provision of additional data and analysis. The Department subsequently published its Notice of Intent to find the ILA, DCA docket no. 27-01, consistent with the minimum requirements of Sections 163.31777(2) and (3), Florida Statutes, and the Act.

A petition for hearing by Brooksville Quarry, LLC, was filed on May 21, 2009, pursuant to Section 163.3184(9), Florida Statutes, and assigned Case No. 09-2833GM. The Brooksville Quarry, LLC, petition challenged the Department's ILA consistency determination.

On August 10, 2009, Brooksville Quarry, LLC, filed a Notice of Voluntary Dismissal without Prejudice. An Order entered August 11, 2009, relinquished jurisdiction for Case No. 09-2833GM back to the Department for entry of a Final Order. No disputed issues remain to be resolved in Case No. 08-1549GM, and the time for filing a petition has expired.

ORDER

WHEREFORE, it is ORDERED that the above-captioned proceeding is DISMISSED, and the Agency Clerk is directed to close the file.
