### **FINAL ORDER**

An Administrative Law Judge of the Division of Administrative Hearings has entered an Order Closing File in this proceeding. A copy of the Order is attached to this Final Order as Exhibit A.

#### BACKGROUND

This is a proceeding to determine whether the City of Lake Wales (City) Comprehensive Plan Amendment 08-1, adopted by Ordinance Nos. D2007-09 and D2008-11, on January 15, 2008, is "in compliance" with the Local Government Comprehensive Planning and Land Development Regulation Act, Ch. 163, Part II, Florida Statutes (the "Act").

The parties entered into a Stipulated Settlement Agreement which required the City to adopt certain remedial amendments. The City adopted the remedial amendments and the Department subsequently published its Cumulative Notice of Intent to find Plan Amendment 08-1 and the remedial amendment to be "in compliance" with the Act.

The Department subsequently filed a Motion to Relinquish Jurisdiction. The Administrative Law Judge issued his Order Closing File (copy attached hereto) and relinquished jurisdiction to the Department. No Exceptions to the Administrative Law Judge's Order were filed.

#### **ORDER**

WHEREFORE, it is ORDERED that the above-captioned proceeding is DISMISSED, and the Agency Clerk is directed to close the file.
