FINAL ORDER

An Administrative Law Judge of the Division of Administrative Hearings has entered an Order Closing File in this proceeding. A copy of the Order is attached to this Final Order as Exhibit A.

<u>BACKGROUND</u>

This is a proceeding to determine whether Gulf County's ("County") Comprehensive Plan Amendment 07-AHDB1 adopted by Ordinance No. 2007-13 on August 28, 2007, is "in compliance" with the Local Government Comprehensive Planning and Land Development Regulation Act, Ch. 163, Part II, Florida Statutes (the "Act").

The parties entered into a Stipulated Settlement Agreement which required the County to adopt certain remedial amendments. The County adopted the remedial amendments by Ordinance No. 2009-08 on August 11, 2009. On September 24, 2009, the Department published its Cumulative Notice of Intent to find the Plan Amendment and the remedial amendment to be "in compliance" with Chapter 163, Part II, Florida Statutes, and Rule 9J-5, Florida

Administrative Code. No party filed a challenge to the remedial amendments adopted by Ordinance No. 2009-08 within the 21-day challenge period.

The Department subsequently filed with the Division of Administrative Hearings a Notice of Filing Cumulative Notice of Intent and Request to Relinquish Jurisdiction on November 13, 2009. On November 13, 2009, the Administrative Law Judge issued his Order Closing File. No Exceptions to the Administrative Law Judge's Order were filed.

WHEREFORE, it is ORDERED that the above-captioned proceeding is DISMISSED, and the Agency Clerk is directed to close the file.
