FINAL ORDER

The Adjutant General of the Department of Military Affairs ("Agency") enters this final Order in the above-referenced matter.

PRELIMINARY STATEMENT

On April 11, 2008, Warren Building Company, Inc., filed a Formal Written Protest and Petition for Formal Hearing with the Division of Administrative Hearings ("Division") challenging a proposed award of contract for armory renovations.

Upon conclusion of the Hearing, the parties requested a transcript and timely submitted proposed recommended orders which were considered by the Administrative Law Judge.

On August 20, 2008, the Administrative Law Judge issued his Recommended Order, attached hereto and incorporated herein by reference, in which he recommended that the Agency issue a final Order denying Warren's Petition and approving the intended award of the contract to Concrete Services, Inc. ("CSI"). The Order advised the Warren Building Company, Inc., of its right to submit written exceptions to the Agency within ten

(10) days of the recommended Order. The Warren Building Company, Inc., did not file any exceptions.

FINDINGS OF FACT

The Agency adopts and incorporates herein by reference the Findings of Fact set forth in the Recommended Order.

CONCLUSIONS OF LAW

The Agency adopts and incorporates herein by reference the Conclusions of Law set forth in the Recommended Order.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is therefore ORDERED:

Warren Building Company, Inc.'s Formal Protest and Petition is denied and the award of contract to CSI for armory renovations is approved. This Order is effective upon filing with the State Quartermaster for the Agency.
