FINAL ORDER

This cause came on for consideration of and final agency action on the Recommended Order submitted on November 21, 2008, by Administrative Law Judge (ALJ) R. Bruce McKibben pursuant to a formal hearing conducted under the authority of and pursuant to Section 120.57(1), Fla. Stat., on October 27, 2008, in Sarasota, Florida. No exceptions were filed.

The Recommended Order (a copy of which is attached as Exhibit A), the exhibits admitted into evidence, the record testimony, and applicable law were all considered during the promulgation of this Final Order.

SCRIVENER'S ERRORS

A review of the record reveals minor scrivener errors that, while they do not materially affect the Findings of Fact or Conclusions of Law in the Recommended Order, should, nonetheless be corrected.

1) The ALJ misspelled Mrs. Rexford's first name. The correct spelling is "Tabatha".

- 2) The Recommended Order refers to Mr. Rexford as "Neil" even though his name is William Clay Rexford. The name "Rex Neil" comes from the first syllables of both Mr. and Mrs. Rexford's last name (the maiden name of Mrs. Rexford).
- 3) Also, the ALJ made a finding of fact in paragraph 8 that "apparently" no checks were written to Mr. Rexford out of the Rex Neil, Inc. account. However, there were several \$25.00 checks written to Mr. Rexford from that account (Exhibit 7, page 119).


Now, having reviewed the Recommended Order, the transcript of proceedings, the exhibits entered into evidence, and applicable law,

IT IS HEREBY ORDERED AND ADJUDGED that the Findings of Fact and Conclusions of Law in the Recommended Order are adopted as the Department's Findings of Fact, and that the Conclusions of Law reached by the Administrative Law Judge are adopted as the Department's Conclusions of Law. The scrivener errors referenced above are corrected as noted.

IT IS THEREFORE ORDERED that Rex Neil, Inc., shall pay the sum of \$1,000 to the Department within 30 days hereof, and that the Stop Work Order entered by the Division of Workers' Compensation are affirmed, and that Rex Neil, Inc., shall cease all business operations unless and until it provides evidence satisfactory to the Division of Workers' Compensation of having now complied with the workers' compensation law by securing the necessary workers' compensation coverage for covered employees and,

pursuant to Section 440.107(7)(a), Florida Statutes, paying the civil penalty imposed herein.
