BACKGROUND

This is a proceeding to determine whether Orange County's ("County") Comprehensive Plan Amendment 2008-1-A-1-4 adopted by Ordinance No. 2008-09 on June 10, 2008, is "in compliance" with the Local Government Comprehensive Planning and Land Development Regulation Act, Ch. 163, Part II, Florida Statutes (the "Act").

The parties entered into a Stipulated Settlement Agreement which required the County to adopt certain remedial amendments. The County adopted the remedial amendments by Ordinance No. 2010-01 on February 16, 2010. On April 1, 2010, the Department published its Cumulative Notice of Intent to find the Plan Amendment and the remedial amendment to be "in compliance" with Chapter 163, Part II, Florida Statutes, and Rule 9J-5, Florida Administrative

Code. No party filed a challenge to the remedial amendments adopted by Ordinance No. 2010-01 within the 21-day challenge period.

The Department subsequently filed with the Division of Administrative Hearings a

2010. On April 27, 2010, the Administrative Law Judge issued his Order Closing File. No
