FINAL ORDER DISMISSING PETITION FOR RELIEF FROM AN UNLAWFUL EMPLOYMENT PRACTICE

This matter is before the Commission for consideration of the Recommended Order of Dismissal, dated October 30, 2008, issued in the above-styled matter by Administrative Law Judge T. Kent Wetherell, II.

Findings of Fact and Conclusions of Law

The matter was before the Administrative Law Judge on Respondent's motion to dismiss. The motion argued that the matter should be dismissed because no employment relationship existed between Petitioner and Respondent. Judge Wetherell issued an Order to Show Cause directing Petitioner to address this issue, but Petitioner's subsequent filing did not allege any facts that might establish that Respondent was Petitioner's employer. Judge Wetherell concluded that because the pleadings do not raise any disputed issues of material fact as to whether Respondent was Petitioner's employer, it was appropriate to relinquish jurisdiction to the Commission for entry of a final order.

We agree that the record of this case reflects that relinquishment of jurisdiction to the Commission is appropriate. Accord, Newton v. Pensacola Glass Company, FCHR Order No. 05-001 (January 31, 2005) in which upon Petitioner's failure to respond to Requests for Admission the matters contained therein were deemed admitted, there were no disputed issues of material fact remaining to be litigated, and the Administrative Law Judge consequently relinquished jurisdiction of the matter to the Commission.

Further, we adopt the Administrative Law Judge's findings of fact and conclusions of law which lead to the determination that it has not been established that Respondent was Petitioner's employer, and that, therefore, the discrimination claim brought against Respondent by Petitioner should be dismissed. Accord, <u>Huth v. National Admark Corporation</u>, 23 F.A.L.R. 4075 (FCHR 2001) in which a Commission panel adopted conclusions of law indicating that the matter should be dismissed because "[a]bsent a showing that she was an applicant for employment or that she

became an employee, the Petitioner lacks a statutory basis for seeking relief from an unlawful employment practice."

Exceptions

Neither party filed exceptions to the Administrative Law Judge's Recommended Order of Dismissal.

Dismissal

The Petition for Relief and Complaint of Discrimination are DISMISSED with prejudice. The parties have the right to seek judicial review of this Order. The Commission and the appropriate District Court of Appeal must receive notice of appeal within 30 days of the date this Order is filed with the Clerk of the Commission. Explanation of the right of appeal is found in Section 120.68, Florida Statutes, and in the Florida Rules of Appellate Procedure 9.110.
