PARTIAL FINAL ORDER

Petitioner Department of Community Affairs (Department or DCA) filed a petition for hearing on October 6, 2008, with the Division of Administrative Hearings (DOAH) pursuant to Section 163.3184(10), Florida Statutes. This petition alleged that certain comprehensive plan amendments adopted by Marion County Ordinance Number 08-25 on July 23, 2008, were not in compliance, and requested that an administrative law judge be assigned to this matter. Intervenor 484 Partners, LLC, the owner as to the parcel of real property covered by Amendment 08-L21, and the Department have entered into a Stipulated Settlement Agreement (Agreement) partially settling the case and resolving all disputed issues related to Amendment 08-L21. On May 4, 2009, pursuant to the Agreement, the Department published an Amended Notice of Intent finding Amendment 08-L21 as adopted by Ordinance 08-25 "in compliance." A copy of the Amended Notice of Intent is appended hereto as Exhibit A. The Amended Notice of Intent eliminates the compliance issues for Amendment 08-L21. Accordingly, the Department filed a Motion to Relinquish Jurisdiction of Matters Pertaining to Amendment 08-L21 to the Department of Community Affairs (Motion) on June 9, 2009. The Administrative Law Judge issued an Order granting the Motion on June 23, 2009, relinquishing jurisdiction for Amendment 08-L21 to the Department. A copy of the Order is appended hereto as Exhibit B.

ORDERED that Amendment 08-L21 is "in compliance," this proceeding is partially dismissed, and the Agency Clerk is hereby authorized and directed to close the file in this proceeding for Amendment 08-L21.
