

FINAL ORDER OF THE AGENCY

THIS MATTER came on to be heard on the RECOMMENDED ORDER in this cause dated February 13, 2009. By unanimous vote the Board of Trustees adopted the RECOMMENDED ORDER as the FINAL ORDER OF THE AGENCY; thus

- 1) THE FINAL ORDER OF THE AGENCY is verbatim the same as the RECOMMENDED ORDER entered by Larry J. Sortin, Administrative Law Judge on February 13, 2009, a copy of which is attached hereto as Exhibit A which is incorporated herein and made a part hereto.
- 2) That no written exceptions were filed by either party to the RECOMMENDED ORDER.
- 3) That the RECOMMENDED ORDER was unanimously adopted at the March 23, 2009 regularly scheduled meeting of the Board of Trustees of Florida Keys Community College.
