

IT IS HEREBY FURTHER ORDERED that the Recommendation made by the Administrative Law Judge is adopted by the Department, and BACKFLOW DIVISION OF SYSTEMS GROUPS, INC., and ROBERT H. RICHEY, SR., are ordered to CEASE and DESIST from engaging in the business of layout, fabrication, installation, inspection, alteration,

repair, or service of fire protection systems, other than preengineered systems until certification is obtained pursuant to Chapter 633, Florida Statutes.
