FINAL ORDER

The Adjutant General of the Department of Military Affairs ("Agency") enters this final Order in the above-referenced matter.

PRELIMINARY STATEMENT

On November 26, 2008, Petitioner filed a Formal Written Protest and Petition for Formal Hearing with the Division of Administrative Hearings ("Division") challenging a proposed award of a security guard services contract.

Upon conclusion of the Hearing, the Petitioner and Respondent timely submitted proposed recommended orders which were considered by the Administrative Law Judge. On May 1, 2009, the Administrative Law Judge issued her Recommended Order, attached hereto and incorporated herein by reference, in which she recommended that the Agency issue a final Order approving the award of RFP No. DMA-RFP-112 to First Coast Security Services, Inc. The Order advised the Petitioner of its right to submit written exceptions to the Agency within ten (10) days of the recommended Order. The Petitioner filed a timely exception and it has been duly considered by the Agency.

RULING ON EXCEPTION

The Agency has reviewed Petitioner's Exception and the Agency rejects the Exception. There is competent, substantial, evidence in the record to support the findings and conclusions of the Administrative Law Judge.

The Agency adopts and incorporates herein by reference the Findings of Fact set forth in the Recommended Order.

CONCLUSIONS OF LAW AND RECOMMENDATION

The Department of Military Affairs approves the award of RFP No. DMA-RFP-112 to First Coast Security Services, Inc. This Order is effective upon filing with the State Quartermaster for the Agency.
