

FINAL ORDER

THIS CAUSE is before me for entry of a Final Order. The Recommended Order concludes that petitioner did not establish that she met the qualifications for licensure as a child care facility provider under section 402.302, et seq., Florida Statutes, and chapter 65C-22, Florida Administrative Code. The administrative law judge (ALJ) found that petitioner failed to meet minimum criteria for licensure and that petitioner falsified her license application. The ALJ recommended that petitioner's application be denied. No exceptions to the Recommended Order were filed. The Recommended Order is approved and adopted.

Accordingly, petitioner's application for a child care facility license is DENIED.

A PARTY WHO IS ADVERSELY AFFECTED BY THIS FINAL ORDER IS ENTITLED TO JUDICIAL REVIEW WHICH SHALL BE INSTITUTED BY FILING ONE COPY OF A NOTICE OF APPEAL WITH THE AGENCY CLERK OF THE DEPARTMENT OF CHILDREN AND FAMILIES, AND A SECOND COPY ALONG WITH FILING FEE AS PRESCRIBED BY LAW, IN THE DISTRICT COURT OF APPEAL WHERE THE APPELLANT RESIDES, OR IN THE FIRST DISTRICT COURT OF APPEAL. REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA RULES OF APPELLATE PROCEDURE. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
