FINAL ORDER

Having reviewed the Notices of Intent to Impose Fine, attached hereto and incorporated herein (Composite Exhibit 1), the Final Order dated June 11, 2009 (Exhibit 2), and all other matters of record, the Agency for Health Care Administration ("Agency") has entered into a Settlement Agreement (Exhibit 3) with the parties to these proceedings, and being otherwise well-advised in the premises, finds and concludes as follows:

ORDERED:

1. The attached Settlement Agreement, Exhibit 3, is approved and adopted as part of this Final Order, and the parties are directed to comply with the terms of the Settlement Agreement.
2. The Final Order of Dismissal with Prejudice dated June 11, 2009, Exhibit 2, is amended to provide the Respondent 90 days from the rendition of this Final Order to make payment.

3. Respondent shall pay, within ninety (90) days of the date of rendition of this Order, the amount of ten thousand dollars (\$10,000.00).

4. Respondent shall pay, within thirty (30) days of the date of rendition of this Order, the amount of one hundred fifty dollars (\$150.00).

6. Unpaid amounts pursuant to this Order will be subject to statutory interest and may be collected by all methods legally available


7. The Respondent's requests for Administrative proceedings are hereby withdrawn


